

## SMOKE ALARM COMPLIANCE IS REQUIRED

## It's not an option, it's the law

All states in Australia have strict legislation relating to smoke alarms in residential rental properties. In all cases, a person who does not comply with the smoke alarm legislation is guilty of an offence carrying penalties of up to \$500. According to some insurance product disclosure statements, non-compliance to current smoke alarm legislation could result in rejection of claims and penalties applied.

It is your legal responsibility to ensure all State and Federal legislation associated with your investment property are complied with. The maintenance required is outside the expertise of property managers as it must be completed to rigorous standards. To protect you from fines and potential litigation, we must obtain proof in writing that your property/ies comply with current legislation.

Did you know that smoke alarms are required to be checked, tested and cleaned and that it is the landlord's responsibility to maintain? Are you qualified to do this? Non compliance is not an option.
