

Property Frenzy Terms and Conditions

By entering the PRD Real Estate Coffs Harbour Property Frenzy competition, you acknowledge and agree that:

- The promoter of this competition is Silpen Pty Ltd.
 (ABN 41 934 483 704 Address: 181 Harbour Drive, Coffs Harbour NSW 2450).
 ('Promoter').
- 2. Entry is only open to residents located in Australia who are aged 18 years or over.
- 3. Employees of the Promoter and their immediate families, participating suppliers and agencies associated with this promotion are ineligible to enter. Immediate family includes a spouse, child or step-child, parent, step-parent, grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
